



LAB DISCLOSURE FOR THE UK MODERN SLAVERY ACT FOR FY17

I. INTRODUCTION

At **LAB SA**, we believe we have a responsibility to conduct our business in an ethical way. We expect the same from our suppliers, and focus on working with long-term, strategic partners that demonstrate a commitment to engaging their workers, safe working conditions and environmental responsibility. This includes working to combat risks of forced labor, modern slavery and human trafficking.

The present statement is made pursuant to Section 54 of the Modern Slavery Act 2015 and sets out the steps **LAB SA** has implemented to ensure that slavery, servitude, forced or compulsory labour, and human trafficking, collectively **Modern Slavery**, is not taking place in any part of its business or in its supply chains.

II. COMPANY OVERVIEW AND SUPPLY CHAIN STRUCTURE

LAB SA is a subsidiary of **CNIM Group**, and is committing to offer the latest technology (B.A.T.) and competitive solutions that enable our customers to increase the profitability of their thermal plants while reducing drastically consequences on environment, for AIR, WATER and EARTH. We act to achieve these goals as a globally engineering, construction and services entity, providing to its worldwide customers integrated solutions.

We are focusing on quality, long-term supply agreements with our suppliers that are committed to our strict standards of sustainability and product excellence. As part of our growth strategy, we seek suppliers all around the world, increasing our relations with partners located in Southern-East Asia area and Northern Africa area. At the 1st of January 2018, about 80% of our suppliers are located in Europe.

III. POLICIES AND PRACTICES

LAB SA commitment is to act with integrity in all its business dealings, and to promote ethical conduct to enhance compliance with applicable laws, and to provide guidance with respect to business conduct.

As subsidiary of **CNIM Group**, **LAB SA** is applying charters and general codes coming from the group, and most particularly:

IV. SUPPLIER DUE DILIGENCE

LAB SA ensures that its new suppliers are carefully chosen by performing audit prior to placing the first purchase order.

For each contract with **LAB SA**, it is mandatory for our suppliers to commit themselves to our general rules and values, by signing our Purchasing Conditions which include a paragraph dealing with risk of **Modern Slavery**.

In addition, any new supplier has to commit his organization on the respect of these rules by answering **LAB SA** Purchasing Qualification Questionnaire which contains a statement dealing with risk of **Modern Slavery**.

V. TRAINING AND AWARENESS

LAB SA conducts regular trainings for its employees to ensure compliance with legal requirements in order to enable us to reduce business risk of non-compliance regarding **Modern Slavery**. All documentation, policies and updates are provided to everyone within the company for easy access via the internal employee portal.

We will still continue to respect the human rights and to promote it in the countries where we and our suppliers operate.
